- Installation experience refers to onsite participation in the installation of concrete pavers. Do not include any projects on which work has not yet begun, or for which you were not an on-site participant in the installation.
- Installation experience can be taken from any period of time that a person has been installing. Installers can go back as many years as needed to fulfill the requirement.
- Projects included on this application must be from PICP installations only.
- Please note that your installation experience needs to be submitted only once. You will not be required to submit this application again.
- The Record of Completion received for passing the Concrete Paver Installer course does not expire, so if you do not currently meet the minimum installation experience requirements, you can wait until you do meet them, and submit your application at that time.
